#### Helpful Hints:

**DRT**: IRS Data Retrieval Tool via FAFSA on the Web allows you to link your 2021 Federal tax information directly from the IRS to FAFSA (highly recommended).

**TRT**: Tax Return Transcript: A transcript can be obtained from the IRS of your 2021 Federal tax return by visiting <u>www.irs.gov/transcript</u>, following the prompts to obtain "Get Transcript".
